This has reference to your online application dated 04 Jan 2017 seeking information with regard to the procurement of materials from Small Scale Industries (SSI) under the provisions of RTI Act, 2005.

2. The information sought vide your application is not available in the desired format. However the information to the extent of its availability is furnished hereunder:

- i) Total no. of tenders issued during Jan 15 to Dec 15 are 1575 out of which 429 are issued for MSME / SSI.
- ii) Total no. of tenders issued during Jan 16 to Dec 16 are 1854 out of which 568 are issued for MSME / SSI.
- iii) Total value of items procured from SSI units during Jan 15 to Dec 15 is approximately about Rs. 28.55 Crores.
- iv) Total value of items procured from SSI during Jan 16 to Dec 16 is approximately about Rs. 34.5 Crores.
- v) The list of items procured includes pipes and pipe fittings, valves, hardware, electrical, rubber & safety items, spun yarn, asbestos cloth, SS manufacturing items, brass manufacturing items, gun metal manufacturing items, SS fasteners, brass fasteners, rubber items, GI manufacturing items, GI wire mesh, MS wire nails, flexible hoses, zinc anodes, welding electrodes, oil joints, Teflon bushes, brass port holes, rubber solutions, SS ATU filters, Brass name tallies, EPDM rubber packings, red oxide paint, grease, wooden panelling, GI pipes, other shipbuilding components and general items.

3. In case you are not satisfied with the above reply, you may prefer an appeal under section 19(1) of the Right to Information Act, 2005 to the appellate authority, Cmde. PHM Salih, D(CP&P) within a period of 30 days of receipt of this communication.
